#### Te Awa River Ride

Te Awa River Ride has attracted large numbers of cyclists since it opened late last year. While many users are courteous and safety conscious when passing through Hammond Park, a disappointlingly stubborn proportion are refusing to dismount which is dangerous and distressing for other boardwalk users. The RESI committee has been in ongoing discussions with HCC personel on how to address this problem. In the meantime, the boardwalk is closed for 3 months through July to September while remedial work is undertaken by contractors to replace the decking and side rails.
